Information We Collect

- To process merchandise orders, including shipping and customer support
- To process sweepstakes entries and notify winners
- To acknowledge donations and provide receipts
- To improve our website and enhance your user experience

Sharing Your Information

We do not sell, rent, or trade your personal information. We may share your data with:

- Trusted third-party service providers who assist with website operation, payment processing, order fulfillment, and communications
- Legal authorities, if required by law or in response to a legal process (e.g., court order or subpoena)

These third parties are bound by confidentiality agreements and are only permitted to use your data to perform the contracted services.

Data Security

We implement physical, technical, and administrative safeguards to protect your personal data from unauthorized access, disclosure, alteration, or destruction.

In the event of a data breach compromising your personal information, we will take immediate action to investigate the cause and nature of the breach. Notification will be made via email within 14 days of becoming aware of the breach. The notification will include details regarding the nature of the breach, what information was affected, measures taken to prevent recurrence, and our contact information for any questions.

Data Retention

We retain your personal data only as long as necessary to fulfill the purposes outlined in this policy.

Your Rights and Choices

You have the right to:

- Access your personal data
- Correct inaccuracies in your data
- Delete your data
- Object to or restrict processing
- Withdraw consent (where applicable)
